# MINUTES

**ABSENT:** Linda Hamilton, Mike Clark, Juan Carlos Valle, Claire Syrett

Ms. Lange called the meeting of the Eugene Police Commission to order at 5:32

## **Agenda Review**

Ms. Hawley reviewed the agenda and related materials, and announced that Mr. Valle will not be at the meeting.

## **Minutes Approval**

Moved by Mr. Tyndall, seconded by Ms. Miller to approve the minutes as presented. The motion passed unanimously.

## **Public Forum**

Deb Frisch supported the idea of not holding meetings at 300 Country Club Road. She expressed concern with the Office of the Police Auditor, and the ethics of the current policy which calls for optional external review of internal cases. She believes all internal cases should be reviewed externally. She expressed disappointment with Chief Kerns in supporting unreasonable use of force in a recent case.

Carol Berg Caldwell – supported meetings for 6 months at 300 Country Club, and then 6 months at neighborhood associations. She asked that the discussion of Criminal Trespass be placed at the beginning of the upcoming committee agenda so the topic is not deferred a third time.

## **Comments from Chair and Items from the Commission**

Ms. Conover – No Civilian Review Board meeting, so no update.

Mr. Walker – Supported idea that Criminal Trespass issue will be put at the beginning of the next meeting of the committee reviewing policies.

Mr. Garner – He and his wife will be attending the gang symposium on Saturday.

Mr. Tyndall – Reported on recent mass arrest regarding curfew. Commended the department on handling the arrests well.

Mr. Lohrke – Noted that today's newspaper included a photo of a firearm seized in arrest. He asked how the newspaper received the picture.

Mr. Manning – Thanked the Chief for providing a response to his question regarding the frequency of burglaries and alarm systems. He hopes that EPD will consider beginning to collect this information. Thanked Chief for Department's response to a threat at EWEB

Ms. Miller – Thanked Chief for response to bomb threat at Sacred Heart, and thanked the Department for its response at the schools in December.

Ms. Lange – Encouraged all Commissioners to attend the gang symposium

### **Chief's Report**

Arrests for SLEEPS were for criminal trespass, not curfew. He committed to explain the release of the picture of the weapon.

The Chief reviewed recent crime trends and upcoming activities.

Ms. Lange asked about presentation from call takers. Ms. Lange will work with staff to schedule.

Mr. Walker asked how unincorporated county statistics are counted. Chief Kerns responded that the County data is not included in the City's crime information. Additionally, the County does not take reports on all burglaries, so the data is incomplete.

Ms. Miller asked whether there has been discussion locally about increasing police presence at schools. Chief Kerns said he has not been involved, but he believes the school districts are discussing the topic.

### **Meeting Locations**

Mr. Manning believes it would be good to have meetings elsewhere but that it might not be practical.

Ms. Conover spoke with Mr. George Rode who will be assuming Police Commission seat for the Civilian Review Board liaison. He suggested that the meeting location should not change.

Ms. Lange supported the 300 Country Club location. She encouraged better advertising and sharing information about transit.

Mr. Walker said that meeting until 9:00 limits the choices. He favors remaining at 300 Country Club.

Mr. Lohrke suggested that the meetings should not be at a building with the police logo because the Police Commission must be seen as independent. He supports meeting at the Campbell Center.

Mr. Tyndall supports the idea of meeting in a common location. He encourages the location within walking distance of the bus station. He supported the idea of meeting at Cozmic Pizza as they are interested in increasing the public meetings.

Ms. Miller supports the idea of bus access, and suggests this need should be balanced with free and easy parking access. She is concerned about safety at some of the locations downtown.

Mr. Manning noted the Council does not move its location. He supports this location, and acknowledges that perception is important.

Mr. Manning moved that the Commission meet at a consistent location and remain at 300 Country Club until City Hall establishes a location and then move in to where City Hall locates. Seconded by Ms. Miller.

Approved 6 (Walker, Garner, Conover, Lange, Miller, Manning) to 2 (Lohrke, Tyndall)

### **Downtown Public Safety Committee**

Chief provided an update on the members of committee, and that there is to be one representative from Police Commission to be decided by the Police Commission.

Ms. Miller urged the commission to select someone who could poll the balance of the commissioners and reflect a balanced perspective.

Ms. Conover nominated Ms. Miller. Accepted by Ms. Miller.

Mr. Walker nominated Mr. Tyndall. Accepted by Mr. Tyndall.

Ms. Miller nominated Mr. Valle. Mr. Valle was absent, but had expressed interest the day of the meeting in being considered, so the nomination was deemed accepted by Mr. Valle.

Mr. Walker urged the Committee to develop a recommendation that retains the safety downtown.

Ms. Miller received 6 votes (Walker, Conover, Manning, Miller, Garner, Lange)

Mr. Tyndall received 2 votes (Tyndall, Lohrke)

Mr. Valle received no votes.

### **Committee Reports**

Mr. Tyndall reported that the last Outreach Committee meeting was cancelled however he met the public who came for the meeting, and received their comments. The meeting was rescheduled for January 15.

Mr. Walker provided an update of the last Policy Screening meeting, where the Park Restriction was discussed.

### **Closing Comments**

Ms. Lange – Apologized to the public for cutting off discussions with the public, and encouraged the public to bring issues to her directly.

Ms. Conover announced that this was her last meeting. She thanked Ms. Hawley for staffing the Commission, Chief Kerns and staff for their support and bringing perspective. She thanked the public who attends. She recommends that the Policy Committee solicit community input and share that with the Department.

Mr. Walker thanked Ms. Conover for her service. He is concerned about the state of public safety, given the financial challenges and loss of jail space.

Mr. Garner thanked Ms. Conover. He thanked Mr. Tyndall for moving the last Outreach Committee meeting, and congratulated Ms. Miller for appointment to the DPS Committee.

Mr. Tyndall thanked Ms. Conover.

Mr. Lohrke reported that a result of the Policy Committee is that the Police and Parks Departments will work together to look at how the duration of park exclusions are established. He thanked Ms. Conover.

Mr. Manning thanked Ms. Conover for her wit, honesty and fire. Mr. Manning read a letter he wrote to a neighbor in his home ownership association regarding gun ownership.

Ms. Miller thanked Ms. Conover and her willingness to share the perspectives. She thanked members of the public for attending the public meetings. She asked about Council appointments.

Ms. Conover moved to adjourn. Mr. Garner seconded. The motion passed unanimously.

The meeting adjourned at 7:15pm


