A parking permit entitles the undersigned employee to park a vehicle(s) in any available marked parking space in the parking lot assigned by the permit subject to the following considerations and terms:

1. The undersigned agrees to abide by all applicable regulations prescribed by the City Code. Your parking permit is subject to all such regulations.
2. The City of Eugene reserves the right to adjust any and all fees covered under this agreement and also reserves the right to cancel the permit at any time.
3. Purchase of the permit is not a guarantee of a parking space in the assigned parking lot, but is a permit to park, if there is a space available.

Payroll Deduction Authorization: The undersigned employee agrees to allow the City of Eugene to take twice-monthly payroll deductions for parking permit fees each calendar month, plus deductions for any adjustments that are needed in the administering of this Parking Permit agreement.

1. Deductions will begin or end on the "Effective Month" listed at the top of this form.
2. The deductions for a month will be taken on the first and second paychecks of that month.
3. The deductions will continue until either the employee **notifies PAYROLL** of their intention to cancel or employment is terminated.
4. The parking deductions are for a full month regardless of what portion of a month the permit is actually used by the employee.

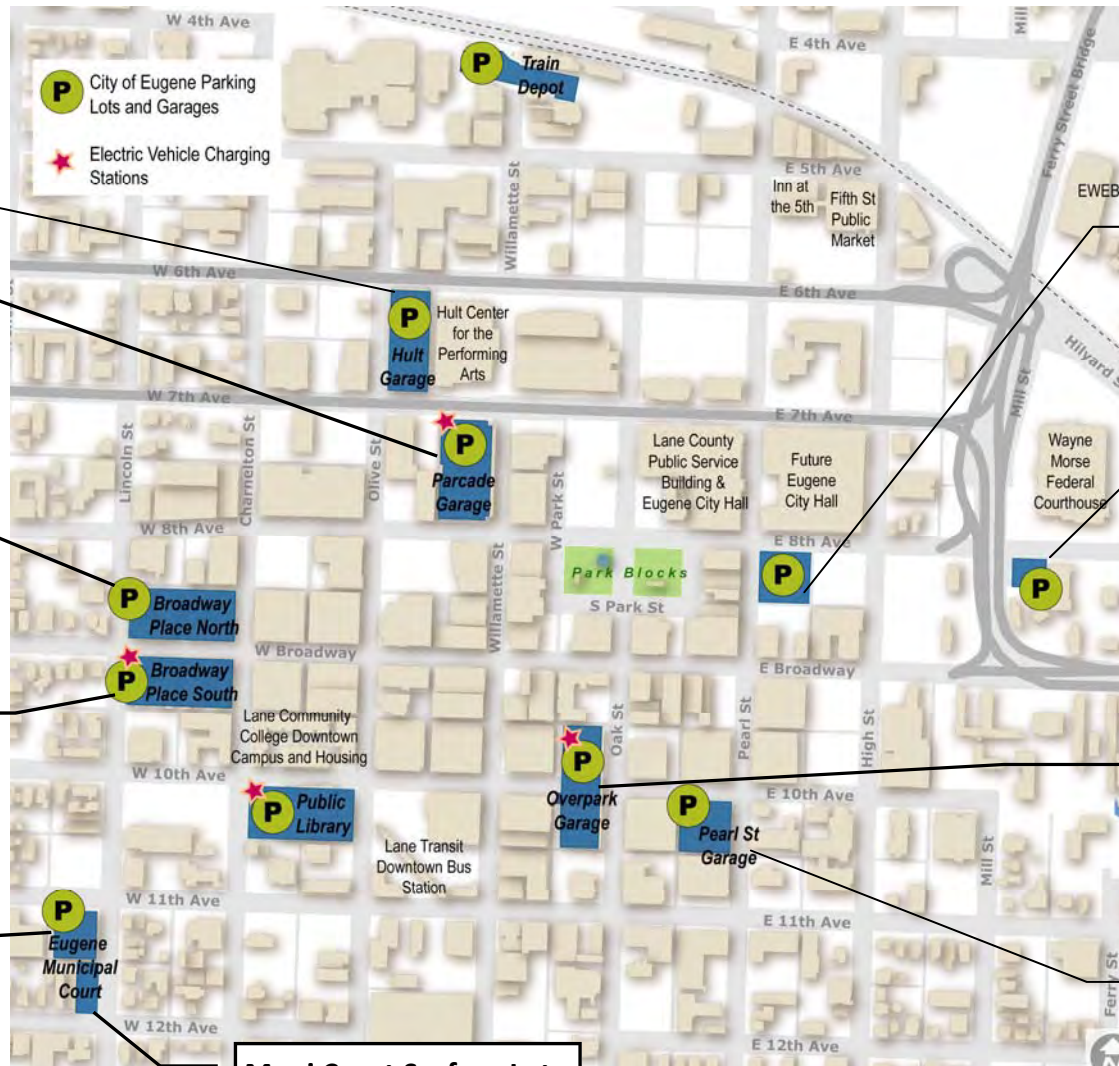
