Commercial providers owning telecommunications facilities located in the public rights of way (ROW). *Ord 20083 Obligations: Registration; Licensing; 7% licensing/ROW use fee; 2% registration fee/tax unless otherwise restricted by law or existing franchise. If no Eugene customers or receipted Eugene earned income, a separate agreement for rights of way use is executed. ROW Licenses expire in 20 years if not renewed.*
