1. **Project Value** – To what extent does the project improve the existing structure?
2. **Project Design** – Is the design tasteful and consistent with the structure's original appearance?
3. **Project Feasibility** – Is the project feasible given the proposed budget and timeline?
4. **Significance / Integrity of Existing Structure** – Does the structure still have historical significance?

Disclaimer and Signature

- Projects must be completed one (1) year after awards announced.
- If a building permit is required the work SHALL be completed by a licensed, professional contractor.
- Funding is limited and awards are based on a dollar-for-dollar match.
- **Funds will not be awarded until the project is complete**, and has been inspected by City Planning Staff.
- Failure to comply with any applicable grant criteria or State/Federal requirements will constitute a breach of the grant contract. Such a breach will result in loss of grant funds.
