

PAYDAY LENDER LICENSE RENEWAL APPLICATION INSTRUCTIONS

Oregon State Statute Chapter 725.600 requires Payday Lenders to obtain a state issued license prior to conducting business to provide certain consumer loans. City of Eugene Code Chapter 3 regulates the Payday Lender industry and requires each lender location to apply for and receive a license. The annual license fee for each payday lender location is \$500.00 payable at the time of application.

Any payday lender not in compliance with the Eugene Code and Administrative Rules pertaining to payday loans may be subject to civil penalties up to \$1,500 per occurrence.

To apply for an initial license:

Complete a Payday Lender Application form for each location within the Eugene city limits and submit it with the \$500.00 license fee per location. All information on the application form is required and a copy of the payday lender fee schedule and other documents as listed must be submitted with the application.

To renew (annually) an existing license:

Complete a Payday Lender Renewal form for each location within Eugene city limits and submit it with the \$500.00 license fee per location. All information on the renewal form is required and a copy of the payday lender fee schedule and other documents as listed must be submitted with the renewal form.

Renewal forms are due no later than 30 days prior to the current license expiration date.

License will be sent to the business mailing address listed on the application.

Complete a Payday Lender application form for each location within Eugene city limits and submit it with a \$500.00 license fee per location. All information on the application form is required.
