

Farmers Market Pavilion Rental Information



Overview:

The Farmers Market Pavilion is a beautiful, light, and spacious venue with a unique indoor/outdoor atmosphere with roll-up garage doors that lead to a versatile Plaza space. Located in the heart of downtown in Eugene's vibrant arts district, the Pavilion is an easily accessible gathering space designed with elegance and sustainability in mind. The Pavilion is located at 85 E 8th Ave in the Park Blocks. The Pavilion's anchor organization, the Lane County Farmers Market, is not only a place where you can buy fresh, local produce, but also an event where one can meet up with a friend or run into a neighbor. The new Farmers Market Pavilion and Plaza supports this beloved institution, giving the Market more space to grow while showing our community's pride in our local farms and food producers.

Room details:

The Pavilion is a light-filled structure built with cross-laminated timber panels from Riddle, Oregon and measures 8,515 sq. Ft.

- Roll-up doors to allow smooth transition of indoor and outdoor space.
- Food prep area to support sanitary food sample service and event concessions.
- The food prep area has a retractable awning.
- Expanded plaza adding more space for vendors and recreational uses.
- Curb-less streets (like Kesey Square) to connect with the businesses on W. Park Street (to be completed with the 8th Avenue Reconstruction project later in 2022 and into 2023)
- ADA Accessibility
- Restrooms, water fountain and bottle fill.
- Bistro chairs and tables are provided for indoor and outdoor use.
- Additional equipment is available to rent upon availability.

Fees and Rates

The Pavilion will be available for rentals in early 2023. Rates are coming soon!

Cleaning

- Rental groups are responsible for all set-up and cleanup for the event. Make sure to include these needs in your rental time. Please review the attached [Cleanup Checklist](#) for your responsibilities.

Food

- If food is catered, the renter will need to provide a copy of the caterer's liability insurance two weeks prior to the rental date.
- If food is being served and is NOT potluck style or catered, the individual will need to provide proof of liability insurance two weeks prior to the rental date.
- If food is being sold, a temporary restaurant license must be attained.
- Renters must supply all food prep supplies, dishes, utensils, etc. as needed.

Alcohol

- Alcohol may be served on the premises with proof of liability insurance.
- Alcohol sales must be in accordance with Oregon Liquor Control Commission licensing regulations.
- Alcohol rentals must review and sign an Alcohol Use Agreement.
